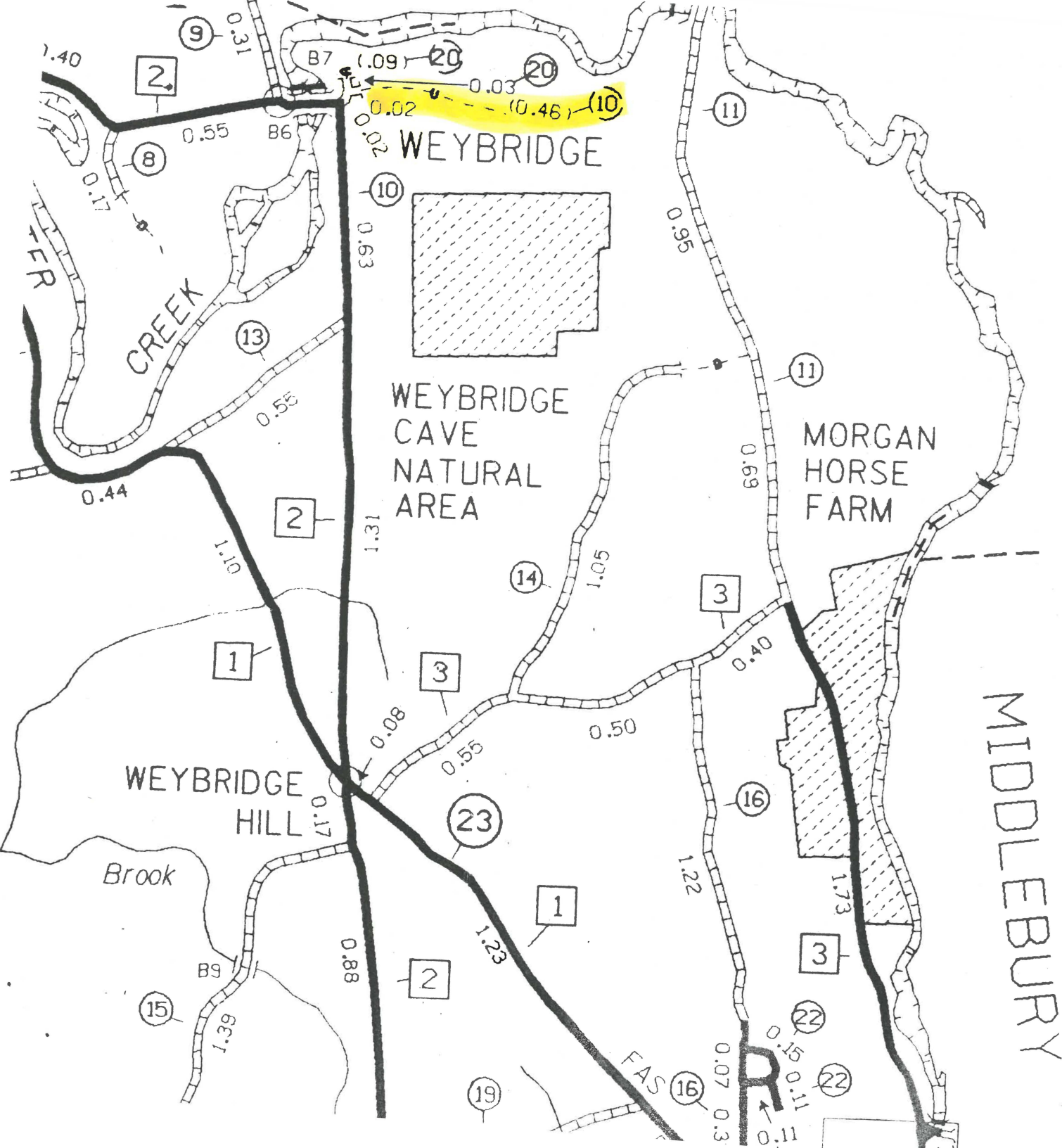

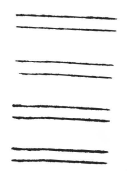

You are hereby notified that a portion of the highway leading from Weybridge Village to the so called turnpike road has been discontinued by order of the selectmen for said Town of Weybridge and the portion of said highway which has been discontinued begins at the westerly line of lands owned by one Izora Newton and lands easterly to the so called old turnpike road running north and south. Said turnpike road leads past Huntington Falls so called. The discontinued highway as above set forth is about three-fourths mile in length.

NOTICE.

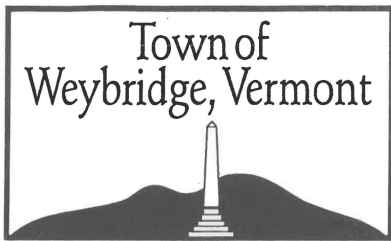
We, the selectmen in and for the Town of Weybridge, Addison County, Vermont, hereby give notice that we will meet at the Town Hall in Weybridge, in said County of Addison, at 2 o'clock P. M. on the 9th day of April, A. D. 1928, for the purpose of examining the premises hereinafter described, and hearing parties interested in the proposed discontinuance of highway described below.

The highway purposed to be discontinued is known as a portion of the road from Weybridge Village to the so-called turnpike road and the portion purposed to be discontinued begins at the westerly line of lands owned by one Izora Newton and lands easterly to the so-called old turnpike road running north and south. Said turnpike road leads past Huntington Falls so-called. Said highway purposed to be discontinued is about three-fourths of a mile in length.
