To Town Clerk and Selectboard:

We received Sunderland's 2009 Certificate of Highway Mileage which noted that 0.05 miles of TH-12 (Red Mountain Rd) had been deeded to the Town of Arlington, but that increase in mileage was not noted on Arlington's 2009 certificate.

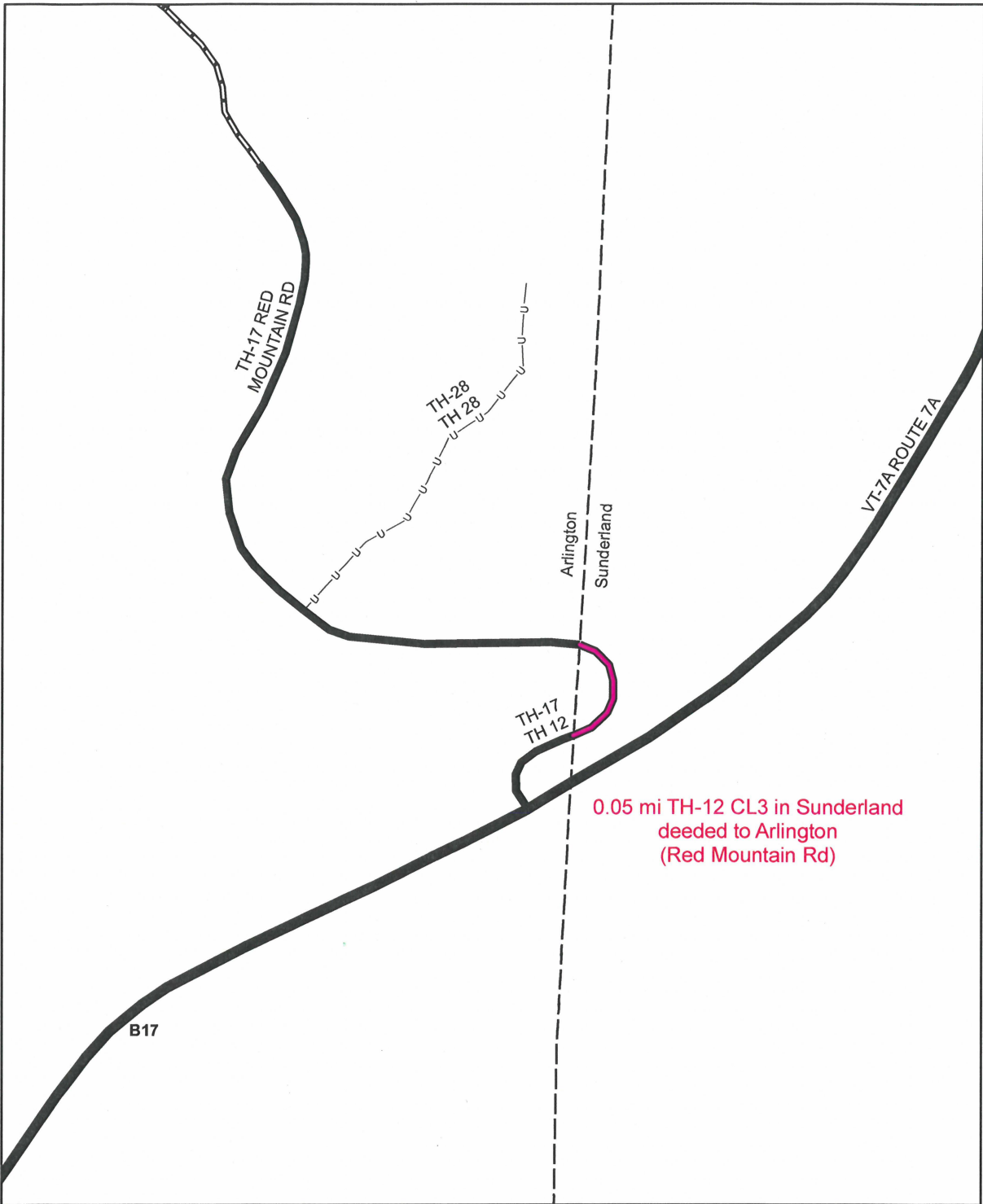
