## CERTIFICATION

### RECLASSIFY A PORTION OF PLEASANT STREET IN EAST DORSET (A CLASS 3 HIGHWAY) TO A TRAIL

This is to certify that the Board of Selectmen at a Regular Selectmen's Meeting on November 19, 1996 instructed the Town Manager to initiate the proper proceedings to change the designation of a portion of Pleasant Street in East Dorset (A Class 3 Highway) to a Trail (3 rods wide).

The Town Manager ascertained all abutting property owners by record review and other means necessary to accomplish notification to all interested parties.

This is to certify that pursuant to T. 19 VSA par. 708 of the Vermont Statutes (*Laying Out, Altering, Reclassifying or Discontinuing Highways by Selectmen*), legal notification was accomplished by posting the following notice in the Manchester Journal on January 2, 1997 and a copy of said notice was sent by certified mail to the Dorset Planning Commission; the Vermont Agency of Transportation District Office; the Vermont Department of Forest & Parks; the Forest Supervisor Green Mt. National Forest; and the entire list of names of abutting property owners.

The notice was also posted in the Town Clerk's Office, Selectmen's Meeting Room, Dorset Post Office & East Dorset Post Office on December 18, 1996.

This is to certify that the Selectboard surveyed said highway on Tuesday January 21, 1997 from 6:45 P.M. to 6:55 P.M. This is to further certify that a public hearing was held to hear all testimony rendered and solicited on Tuesday January 21, 1997 from 7:00 P.M. to 7:10 P.M.

The Selectboard voted unanimously to reclassify a portion of Pleasant Street in East Dorset from a Class 3 highway to a Trail.

The Selectboard has determined that the convenience of the inhabitants of the Town of Dorset and the public good require the alteration of the highway herein described to TRAIL designation and therefore it is hereby ordered by the Selectboard of the Town of Dorset that said highway be altered to the status of a legal trail three rods wide, to be used by the public as a trail and in accordance with the laws of the State of Vermont and the ordinances, by-laws, and regulation of the Town of Dorset providing no further change in the status, width, bounds or use of said highway other than as provided by law.

## RECLASSIFY A PORTION OF PLEASANT STREET IN EAST DORSET (A CLASS 3 HIGHWAY) TO A TRAIL

Pursuant to the laws of the State of Vermont, all abutting landowners, persons interested in abutting lands and other persons who desire to be heard with respect to the ALTERATION OF THE CLASSIFICATION, of a portion of Pleasant Street in East Dorset, situated in the Town of Dorset, Vermont described as follows:


1. Town Highway #35: (95 ft. ~ 0.018mi.) Beginning at the end of pavement at the south end of Pleasant Street and proceeding approximately 95 feet southerly to the property line of the Inez Bebee Estate ( Map 25/ Block 21/ Lot 84) in East Dorset. {More particularly described as beginning at an iron rod set at the southeast property corner of lot 80, map 25, block 21, (now or formerly owned by Carroll B. & Mary Lou Bowen) which point is also the southwest corner of Pleasant St--T.H. #35; thence proceeding N 15° 20' 57" E a distance of 95.10 ft. to an unmarked point; thence S 74° 39' 03" a distance of 50.00 ft. ~the width of the r-o-w~ crossing the end of the pavement of T.H. #35 to an unmarked point on the edge of the r-o-w; thence S 15° 20' 57" W a distance of 99.83 ft. along the property line of lot 77.12, map 25, block 21 (now or formerly owned by Merrick L. Counsell & Rebecca K. Stetson) to an iron rod set at the southwest corner of lot 77.12, which point is also the southeast corner of T.H. #35; thence proceeding N 69° 14' 49" W a distance of 50.22 ft. along the end of T.H. #35 and the northerly property line of lot 84, map 25, block 21 (now or formerly owned by the Estate of Inez H. Bebee) to the point of beginning. }


You are hereby notified that the Board of Selectmen will examine said section of said highway on Tuesday January 21, 1997 beginning at 6:45 P.M.




All persons also are notified that a decision of the Board of Selectmen, with respect to the matter hereinbefore set forth, will thereafter be issued according to law.

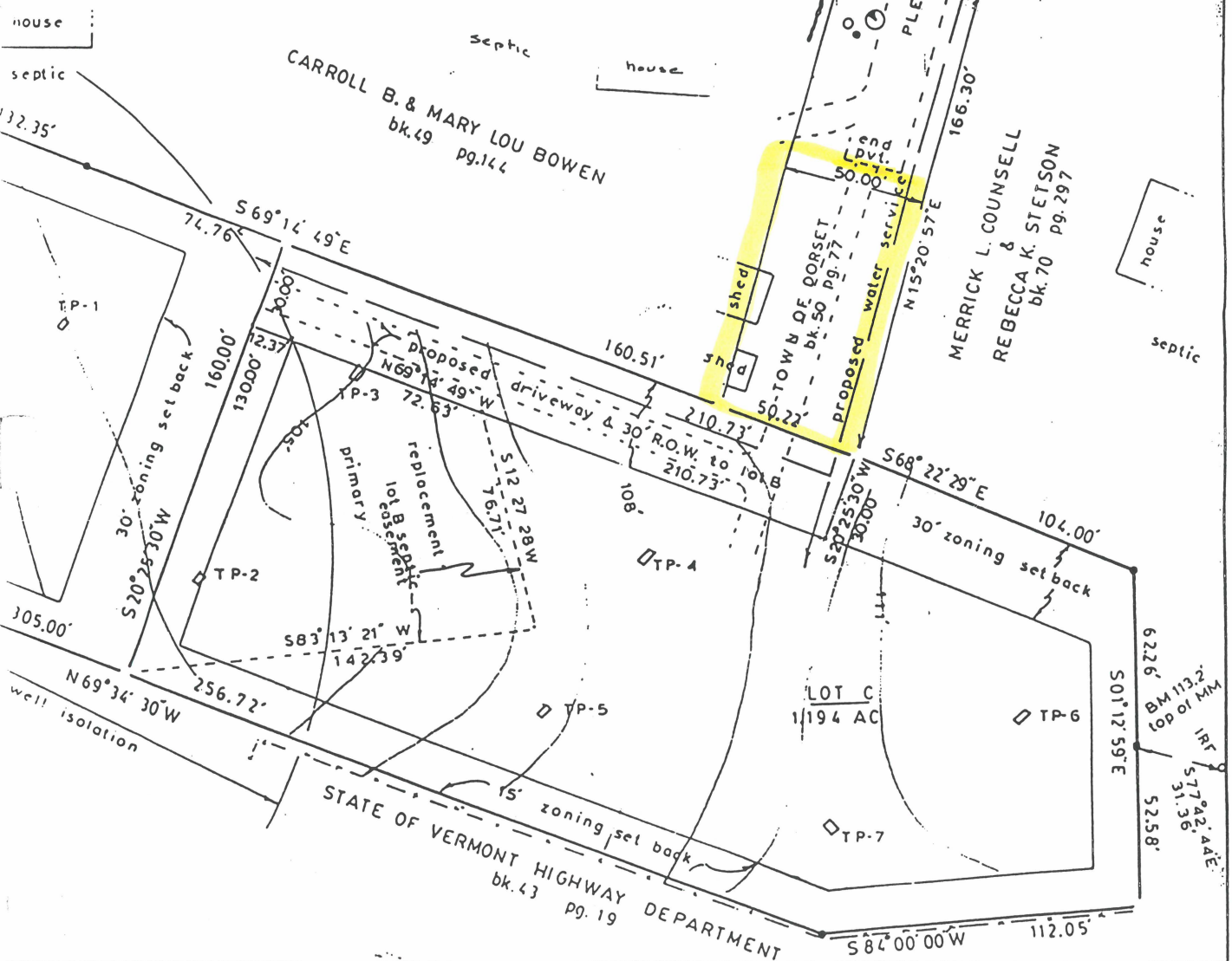
