§ 305. Measurement and inspection

(a) After reasonable notice to the selectboard, a representative of the agency may measure and inspect the class 1, 2, and 3 town highways in each town to verify the accuracy of the records on file with the agency. Upon request, the selectboard or their designee shall be permitted to accompany the representative of the agency during the measurement and inspection. The agency shall notify the town when any highway, or portion of a highway, does not meet the standards for its assigned class. If the town fails, within one year, to restore the highway or portion of the highway to the accepted standard, or to reclassify, or to discontinue, or develop an acceptable schedule for restoring to the accepted standards, the agency for purposes of apportionment under section 306 of this title shall deduct the affected mileage from that assigned to the town for the particular class of the road in question.

(b) Annually, on or before February 10, the selectboard shall file with the town clerk a sworn statement of the description and measurements of all class 1, 2, 3, and 4 town highways and trails then in existence, including any special designation such as a throughway or scenic highway. When class 1, 2, 3, or 4 town highways, trails, or unidentified corridors are accepted, discontinued, or reclassified, a copy of the proceedings shall be filed in the town clerk's office and a copy shall be forwarded to the agency.

(c) All class 1, 2, 3, and 4 town highways and trails shall appear on the town highway maps by July 1, 2015.

(d) At least 45 days prior to first including a town highway or trail that is not clearly observable by physical evidence of its use as a highway or trail and that is legally established prior to February 10, 2006 in the sworn statement required under subsection (b) of this section, the legislative body of the municipality shall provide written notice and an opportunity to be heard at a duly warned meeting of the legislative body to persons owning lands through which a highway or trail passes or abuts.


(e) The agency shall not accept any change in mileage until the records required to be filed in the town clerk's office by this section are received by the agency. A request by a municipality to the agency for a change in mileage shall include a description of the affected highway or trail, a copy of any surveys of the affected highway or trail, minutes of meetings at which the legislative body took action with respect to the changes, and a current town highway map with the requested deletions and additions sketched on it. A survey shall not be required for class 4 town highways that are legally established prior to February 10, 2006. All records filed with the agency are subject to verification in accordance with subsection (a) of this section.


(f) The selectboard of any town who are aggrieved by a finding of the agency concerning the measurement, description, or classification of a town highway may appeal to the transportation board by filing a notice of appeal with the executive secretary of the transportation board.

(g) The agency shall provide each town with a map of all of the highways in that town together with the mileage of each class 1, 2, 3, and 4 highway, as well as each trail, and such other information as the agency deems appropriate.

Here are some excerpts from the Sutton Selectboard Minutes regarding this issue:

Sutton Selectmen's Meeting - August 28, 2014 Draft

Andrew Grieves now presents a document and a map of two roads in Sutton that have been closed; Town highway 13 and 16. The discussion ensues that these roads were not closed properly, not recorded properly and needs to be reopened. He states that they are good trail roads and are important to tourists and that also they are good secondary roads if we have any storm damage. Scott states he will call Shauna with the State of VT to find out about this. George will look in the books to see if anything was previously recorded on these roads. We are in the process of going through the safe and replacing cabinets so it might help in locating the documents needed. Scott asked if we had answered all his guestions and Andrew stated no but we had told him what we are doing to look into the problem. Scott said a reasonable time to find out the information is 30 days.

Sutton Selectmen's Meeting Draft - September 25, 2014

Town Highway 7 was discussed: The select board has been approached by the Vermont Horse Council to see if they can use TH 7 (between Nygren Road and Route 5A - Newark/ Westmore) to ride their horses. Tom Featheringham approached the board to explain his position. He passed out a letter from David Meyers and from the Town of Westmore. Tom explained that the Act 250 permit states no access through Nygren Road. All access will be through 5A only and a barrier will be put up. TH 7 is classified as class 4. Westmore documented TH7 as a pent road. Title 19 VSA 1111 sub-chapter 11 Use of Right away. No one will do anything to a road unless they are granted permission. District 7 has listed TH 7 as a class 4 untraveled. The Town of Sutton has never thrown up this road. Tim feels that we should get advice from District 7. Tom maintains that this not for the public good to open this road for the VT Horse Council to clear and ride on. Tom would like to suggest that the selectmen give Tom a letter and state "use for pedestrian traffic only and has no other use". Tom stated the major issue is the ATV's using road. Legally this is a class 4 road, untraveled and no one has asked to have it maintained. If the road

is questionable, the VT Horse Council will fix the bridge and keep the road open. Before any decisions are made the board needs to receive advice from legal counsel and talk to Shauna at District 7.

Motion was made by Tim to table this until we get advice from legal counsel on TH 7. Joe seconded the motion. Scott will call Peter and give him the document that was received tonight. If is in class 4 untraveled, people need permission from the select board to clear it and find out maintenance responsibility. Scott called for a vote to table the TH 7. All voted affirmative. Motion passed

Bill McCormack would like to know where we are on TH 16. It was advertised in the paper and the neighbors were contacted. Scott stated that this is work in progress. As of a few days ago, we are still working on cleaning out the vault with some things have been recovered, but book 5 is still not found. Since there is a reference to book 5, we need to still look for it. Our town attorney stated that we should start from the start. Scott explained that we need a little bit more time, and we have not forgotten it.

TH 7; Tim read a letter from the Town Attorney Peter Morressette. (attached) Tim Noves asked for a definition of "maintenance". The response given was: A person, other than abutting landowners have 1st rights to the wood in the road. Others need the consent of landowners/selectmen. Title 1111, all maintenance brought before the select board. Tim explained if roads are not accessible, any maintenance has to have the selectmen's permission. Patricia Branon, President, VT Horse Council sent a letter about cleaning the roads for horse access and travel and for safety, etc. Tim discussed pent roads; class 4 roads ; motorized vehicles; selectmen can make motion to make a pent road; Scott talked about culverts and bridges when reclassified on class 4 roads. David & Becky Meyer adjoining land abutters request with Tom Featheringham to make it a pent road and have the previous request of cleaning up the road a separate issue. West of Newark be a pent road; Nygren .56 (1/2 mile); .79 untraveled/impassable to Newark border. Scott: the objective is to keep motor vehicles out unless deemed by selectmen. Joe made a motion to allow clearing requested by VT. Horse Council the width of road to clear traveled portion clearing of saplings hanging over road, downed trees to allow safe passages on horseback. Motion failed with no second.

Tim made a motion to permit Vt. Horse Council to make TH 7 (class 4) passable for safe horse traffic. Joe seconded motion. Scott called for a vote. All voted affirmative. Motion passed Tim made motion to turn a pent road, class 4 section TH7, no motorized traffic with gate of 8' in width (turn .79miles class 4 TH7 Sutton to a pent road with no motorized traffic of any kind with a gate of 8' in length with landowners having permission to use as needed including utilities. Joe seconded motion. Scott made a motioned to amend: property owner, abutters including utilities and first responder emergency vehicles. Tim seconded amendment. Scott called for a vote. All voted affirmative. Amendment Passed. Scott requested Rick to put a "dead end" sign on Nygren's Road http://suttonvt.org/wp-content/uploads/2014/03/Sutton-Selectboard-Meeting-Minutes-October-30-2014.pdf

Sutton Selectmen's Meeting

August 28, 2014 Draft

Chairman Scott Spencer called the meeting to order at 6:05 P.M.

Attending the meeting: Scott Spencer, Tim Simpson, Joe Solinsky, Stacy Spencer, George Colburn, Dee Colburn, Andrew Grieves, Sharon Paton and Laverne Paton

Motion was made by Joe to accept the minutes of July 31, 2014. The motion was seconded by Tim. Scott asked for any discussion, corrections or additions. Hearing none; all in favor to accept minutes as printed, all voted yes.

Scott Spencer asked if there were any new items to be added to the agenda. Andrew Grieves asked to be added and Tim Simpson on behalf of Gary Leach also asked to be added to the agenda.

Scott asks for a motion to accept the treasurer's report. The motion was moved by Tim and seconded by Joe. Scott asked for any discussions. Questions were asked on account balances. Scott asked a question on the reserve account for paving and George answered. The cemetery fund balance and interest was brought up totaling \$8326.03. Tim asked a question on the expenses of WH3700 truck. Joe asked about the expenses and work done on the 3500 truck. Scott stated we are already over budget on the expenditures. There was open discussion on the spending balances and fund for the fire department. Scott asked if there were any more questions on the treasurers report. He then asked if all were in favor to approve the report as printed. All voted yes.

The next discussion was regarding the delinquent tax report and balances. The report is discussed and all figures are gone over.

Tim, representing Gary Leach, states that Gary is in the process of designing the building, cost, etc of the new nitrate treatment system for the village water system. He needs info to meet with us in another week to 10 days to get the final ok to approve everything.

Andrew Grieves now presents a document and a map of two roads in Sutton that have been closed; Town highway 13 and 16. The discussion ensues that these roads were not closed properly, not recorded properly and needs to be reopened. He states that they are good trail roads and are important to tourists and that also they are good secondary roads if we have any storm damage. Scott states he will call Shauna with the State of VT to find out about this. George will look in the books to see if anything was previously recorded on these roads. We are in the process of going through the safe and replacing cabinets so it might help in locating the documents needed. Scott asked if we had answered all his questions and Andrew stated no but we had told him what we are doing to look into the problem. Scott said a reasonable time to find out the information is 30 days.

Sharon Paton with the VT Horse council presents a letter regarding the Nygren road (a class 4 road) going from Sutton to Westmore. They would like access to this road for the use of trail riding. This road has been closed and is not passable. She went to Westmore and they stated the road was closed

improperly/illegally and they removed the lock on the gate across the road. All they are asking is access to this road and permission to cut trees blocking the road. They will cover all costs and labor. Scott will call district 7 and Tim will call the Nygrens. This is time sensitive as they would like to schedule a fall ride. We are asking 30 days to get the answers. End discussion.

Gingue Sand has delivered 2000 yards more sand at the same price as this year and this will be billed in November 2015. We have saved money getting it early but we need to remember to budget this for next year.

Questions raised on Cedar Grove Dance Hall. Do they need a license as they only do private functions? George is going to check with VT City and Leagues to see if they need a permit/license to operate.

Scott asks for a motion on the floor to transfer \$11447.04 from the firehouse fund to the general fund to pay off expenses for the fire department. Tim seconds. Funds will be moved.

Checks and warrants are signed. The check to Larry Seymour is refused. We need breakdown of expenditures. Labor can be paid to Larry but other monies need to be paid directly to the fire department or to the vendor.

Correspondence is gone over. No questions or problems.

Do we bid on salt or go to district 7 for this? There are two companies available; Cargill or American Rock Salt. Salt prices right now are 78 dollars a ton.

Road complaint was filed about Simpson Hill and the town took care of it.

There is a complain letter from Kelly Willey regarding the use of her ATV's and loud truck on the road. They will not make any changes on what they do as she states that members of the town disregard the rules themselves.

Scott makes a motion to adjourn the meeting at 7:48 P.M. Joe moves this. Tim seconds motion. Meeting adjourned.

First order of business:

Floor opened for Chairman: Joe Solinsky nominated Scott Spencer for Chairman; 2nd by Tim Simpson. Joe explained the Health Officer goes along with the Chairmanship. Scott Spencer accepted the nomination for Chairman and Health Officer. All voted in favor

Tim Simpson motioned to use Roberts Rules of Order to run the meetings. Joe 2nd motion. All voted in favor

Scott thanked Joe for his year of service as Chairman. Joe stated this certainly was an interesting year.

The January 26, 2014 minutes were not provided and unable to approve.

Tim made a motion to accept February 27, 2014 minutes as printed. Joe 2nd motion. No discussion; Scott called for a vote. All voted in favor

Motion was made by Tim to approve the March 19, 2014 minutes; motion 2^{nd} by Joe. Discussion was the last paragraph page 2 should read: ".....There was to be an agreement signed between the <u>P & L</u> Riendeau <u>Trucking</u> and Washington Railroad about upgrading the crossing". All voted in favor with corrections.

Tim made a motion to reimburse Clint Gray the bond fee of \$100.00, to bond Mary for \$25,000.00. Joe 2^{nd} motion. All voted in favor

Furnace quotes were reviewed: Quotes submitted: Harris \$8,484.00; Propane Depot \$7,486.69; Jim's Burner Service \$8,145.00.

Motion was made by Joe to use Propane Depot to install the new furnace in the town office with the price quote of \$7,486.69. Tim 2nd motion. All voted in favor

George explained that a new office computer was needed and he received a quote Northeast Computer would cost \$700.00 for a complete system. George stated this will put them over budget. Also, the binding machine has not been paid for yet is part of the reason of being over budget.

Tim moved to authorize the new computer system for \$700.00 for the office. 2nd by Joe. All voted in favor

Clint Gray suggested that the lap top could be used for delinquent taxes and minutes for town business.

George received a letter from the Governor's office for the position of Justice of the Peace. Also a letter was received from Hank Parker the Chair of the Republican caucus stating they do not want to put a republican name in for that position, but would support Danielle Fortin, being an Independent. Tim nominated Danielle Fortin, Joe 2nd nomination. Scott asked that George send an e-mail to Sandy Spaulding at the Governor's office stating that the Sutton Select Board nominated Danielle Fortin for the position of Justice of Peace. All voted in favor

Gary Leach, Tata & Howard. Tim stated we hired Leach engineering for the water system for the town and are in the process to move forward. Gary believes the nitrate removal would be the way to go, but in order to receive funding either from the state or USDA, alternatives need to be given. Since the nitrate is at levels that the USDA considers being a health hazard we would be considered for a grant of up to 75% of the cost. The state also would have zero to low interest loans available. The first date of July 1 to have this completed by was unrealistic, so Ashley Lutt went to the compliance department and they gave Sutton a date of December 1, 2014 to be completed. The selectmen signed the application to begin the process. Both agencies, USDA and State, need to approve this application; it will take about 30 days. The select board also reviewed the engineering agreement, but did not sign it since it was not needed to go with the application. Tim will be the contact person with the backup of Scott, if Tim is not available.

Joe wants to make sure that they, the state or USDA, won't let us go directly to the removal of a nitrate system. Joe said it sounds like the arena has changed since the last meeting even if we choose not to use any grants. Gary stated because this is a public water supply system, we have to conform. Gary stated that if the town used the state or USDA loans, they are both low interest rates with no penalty if it is paid it off early.

Umbrella: Renee Kelley, an Associate of Umbrella and a resident of Sutton explained to the selectmen: At the 2013 Town meeting, the voters had approved an appropriation of \$500.00 to Umbrella but it was never paid to Umbrella. She is here requesting the money be paid to Umbrella for the 2013 appropriation.

Motion was made by Tim that Umbrella be paid \$500.00 appropriation that was approved at the 2013 town meeting. Motion 2nd by Joe. All voted in favor

Tim asked to have the floor: He stated he sign a warrant from the water account for an electric bill from October 2013 that was never paid, it is unclear if there is another bill from August that was not paid and it is being checked on now

George stated that Mr. Soucy wants his taxes abated and he sent that down to Peter Morressette's office.

Larry Francis explained on Friday morning the roads were icy and a car slid into his two cars. Debby Jackson received a call from VSP dispatch at 1:35AM Tim was called at 12:57AM Scott was called earlier. Larry stated the state police said that the roads have to be emergency accessible. The officer said it took him 20 minutes from the Sutton town line to Larry Francis house. Both his cars were totaled by being hit by another vehicle because of icy roads. Larry is now renting a vehicle. Larry thinks the town should be responsible for the extra \$2163.76 that it is costing him. Larry has been here for 8 years, the town ruined his well, Rick dug up the access to the back yard, dug a culvert out, now this. The board asked about the insurance company of the vehicle that struck his vehicles and why they are not paying 100%. Recommendation by Scott, the town does not have responsibility for this, the insurance is stating it is not responsible for the \$2163.76. Scott asked is this is the difference from their payoffs and what the vehicles are worth? Larry said yes. The Board is recommending Larry to hire a lawyer, he said he did and the lawyer said to come to the selectmen. Larry does not know if there were any tickets given to the driver. The selectmen don't feel the town is liable for this.

Andrew Grieves appeared before the board. Town Highway 16 is blocked and it is a public road. Andrew Grieves wanted a letter read into the minutes:

"I am here to request that the Town of Sutton re-open the Benton Road (Town Highway 16). Someone has posted a no trespass sign and the road has been roped off. Town Highway 16 is, and always has been, a public town road. This open and public roadway has been available for driving, hiking, walking, horseback riding and many other uses. It is illegal to restrict the use of this road by a private citizen. Thank you, Andrew Grieves"

Scott wants to hear from District 7 on this and do some research from past minutes. Scott is asking for some time to research this. Debby Jackson will call Ben McCormack to see if he has documentation on this.

Pat Jackson has a letter from Mrs. Beth Townshend requesting a 4 parcel burial lot for her family.

Motion was made by Joe to approve a 4 plot burial lot to Beth Townshend in the Sutton Village Cemetery. Motion 2nd by Tim. All voted in favor

Mary asked the selectmen if she could ask Sue Cheney what the cost would be to clean the office once a month. The town office is very dirty and looks like it has not been cleaned in a year. Mary will research the cost. Scott stated he wants a new Shark Vacuum cleaner for this building. This can be purchased at Wal-Mart for \$225.00, it is bag-less/upright. Suggestion was also to call Mike to get rid of the cluster flies.

Tim made a motion to authorize George or Gail to acquire a Shark vacuum cleaner for the office building. Joe 2nd the motion. All voted in favor

Mary Gray agreed to take the minutes at selectmen board meeting will receive \$12.00/hr. She did request that the meetings not go longer than 3 hours. The board seemed to think that they did not want them to go that long either.

Tim made a motion to pay \$12.00 per hour for minutes taken for board meetings. Joe 2nd motion. All voted in favor.

Gail Weed handed a letter to the selectmen requesting that the position of Assistant Town Clerk/Treasurer be reclassified to a full time position with full benefits. The selectmen asked what full benefits would be and it was explained by George, health benefits, vacation/sick time and retirement. Gail feels that the 16 hours the previous Town Clerk budgeted for is not sufficient to complete the work. Since this is personnel, the selectmen wanted to know if Gail would like to have this conducted in executive session, she declined, stating she did not need it in executive session. Gail has been with the town since December 20, 2012. The selectmen stated to George that they control the budget, but George should come before the board to ask to have this position be full time since he is the one that hires his assistants.

George requested from the selectmen the position of Assistant Town Clerk/Assistant Treasurer be changed from a part time position to a full time position with benefits.

Scott wants to know if they want to keep the meeting open or go into executive session. George did not have a problem keeping the meeting open.

Scott said we need to put a motion on the floor to fund the assistant position; make a motion to turn it from part time to full time; then motion the pay scale.

Gail stated she would forgo the retirement this year if George decided to keep her on, she will ask for retirement in next year's budget

Tim made a motion to turn the Assistant Town Clerk/Treasurer position into full time for 30 hours a week at the same per hour rate. This position is now receiving \$13.50/hr. Motion 2nd by Joe. All voted in favor

George stated he will be changing the office hours by closing Friday afternoons.

A special meeting needs to be set up for paving bids.

Correspondence: George needs a signature from the select board to have Gail put on all the checking/savings accounts.

Selectmen handled correspondence

Gail said there is \$10,000.00 from the state transportation that she has to do research on. George reviewed the treasurer's report that Gail prepared for the board and he is comfortable with it



The VTrans Mapping Section has received a letter via the Vermont Attorney General's Office regarding several town highways within the Town of Sutton. Please find a copy of the letter from Andrew Grieves dated September 21, 2015 attached. I would like to seek clarification on any classification changes that may have occurred to TH-7 (Nygrens Road), TH-13 (Rocky Road), and TH-16 (Benton Drive) as the Mapping Section has these highways mapped with the following classifications:

<u>Town Highway</u>	Name	Class 3 Mileage	Class 4 Mileage
TH-7	Nygrens Road	1.97 miles	0.79 miles
TH-13	Rocky Road	0.60 miles	
TH-16	Benton Drive		1.15 miles

Based on review of our files in the VTrans Mapping Section, there have been no classification changes to the above highways since the establishment of the current classification system under Act 63 in 1973. The current 2015 Town Highway Map of Sutton reflects this information.

If there have been changes regarding the reclassification or discontinuance of the above highways, or any other town highways or legal trails within the Town of Sutton, please forward the documentation and we will include the mileage changes on the upcoming Mileage Certificate. Any changes would then be reflected on the next series of Town Highway Maps.

One main concern that I have is related to TH-13 (Rocky Road) and if it is posted with a "No Trespassing" sign and not open to the public, then it does not meet the class 3 town highway standards as defined in 19 V.S.A. 302 and should not be receiving state aid for maintenance. The standard is defined as follows:

19 V.S.A. § 302. Classification of town highways

(3) Class 3 town highways:

(A) Class 3 town highways are all traveled town highways other than class 1 or 2 highways. The selectmen, after conference with a representative of the Agency shall determine which highways are class 3 town highways.

(B) The minimum standards for class 3 highways are a highway negotiable under normal conditions all seasons of the year by a standard manufactured pleasure car. This would include but not be limited to sufficient surface and base, adequate drainage, and sufficient width capable to provide winter maintenance, except that based on safety considerations for the traveling public and municipal employees, the selectboard shall, by rule adopted under 24 V.S.A. chapter 59, and after following the process for providing notice and hearing in section 709 of this title, have authority to determine whether a class 3 highway, or section of highway, should be plowed and made negotiable during the winter. However, a property owner aggrieved by a decision of the selectboard may appeal to the transportation board pursuant to subdivision 5(d)(9) of this title.

(C) A highway not meeting these standards may be reclassified as a provisional class 3 highway if within five years of the determination, it will meet all class 3 highway standards.

My name is Andrew Grieves. I would like to bring to your attention the closing of 3 town roads, located in the Town of Sutton.

The first road is Nuygrens Road or Town Highway 7 This road is both a Class 3 and a Class 4 road. I was walking down the Town Highway 7 when a gentleman came out and told me to stop trespassing. He said he owned both sides of the road and also the road. And that I was not allowed on it. He did appear to have No trespassing signs on either side of the road but I didn't think he could own the roadway. This road allows access to the Willoughby State Forest, which I was turned back from.

The second closed road is, Rocky Road (Town Highway 13). This is a Class 3 road. All signs of this road seem to be removed. There is just a field there where the road should be, along with No Trespassing Signs.

The third closed road is the Benton Road or Town Highway 16 This is a Class 4 Highway.

This road is approximately a mile long and is blocked at both ends of it. Along with No Trespassing signs. I decided to take pictures of these No Trespassing signs that are located on the eastern end of the roadway.

Last year I brought this matter to the attention of the Town Select board, of Sutton.

After some period of time I was given the answer that all three roads have been legally turned over to private parties.

I then asked when this happened and if I could see the documentation of these transactions.

The answer was no. They couldn't find the documents.

I find this unbelievable. State maps as recent as 2014 (newest maps) continue to show these Town Highways on the maps.

Can we be prohibited access to the Right of Way on these roads?

I am asking if this matter could be looked into. I've enclosed some maps and photos.
