


Good afternoon Susan (and Selectboard),

I wanted to reach out to the Selectboard to...

- 1. Explain the preloaded change on the 2025 Concord Mileage Certificate that was recently emailed to the Town, and
- 2. Inquire whether a public right of way extends beyond where TH-11 is shown on the Town Highway Map.

#### 1. Preloaded Change:

Before Christmas, I spoke with Dane Thorgalsen about class 3 TH-11 (Cosy Nook Rd). He confirmed that it is only maintained to class 3 standards up to where the road takes a sharp right turn right (westward) to follow the river (this unmaintained portion of TH-11 was TH-14 before the dam was put in), but the Town Highway Map has been showing the class 3 portion as continuing 0.21 mi past that right turn before it becomes a class 4 highway for the last 0.09 mi. The portion that is shown in our records as class 4 is highlighted yellow in the following map excerpt:



The NUTS designation is used when our records/documents indicate that the road is class 3 but isn't maintained to class 3 standards. This designation lets us include the mileage of unmaintained roads in the class 4 mileage totals instead of the class 3 totals, and also lets anyone using our data know that they shouldn't expect class 3 road conditions.

Because the NUTS designation is not a reclassification, we also recommend that the Town formally reclassify this portion of TH-11 as class 4 (or legal trail) or discontinue it.

#### 2. Where is the end of the public right of way that starts as TH-11?

I've attached two images showing the area around TH-11. Both show semi-transparent areal imagery over shaded terrain, and showing how we map TH-11. One of those images also shows the Concord parcel data, which suggests that the public right of way extends well past where we've mapped the end of TH-11. Does the town consider the entire length shown in the parcel data to be a public right of way? What about the rest of former TH-14 that lies beyond the

end of the parcel data (the portions that are still above water, that is)? Here is a link to the 1949 Town Highway Map that shows the extent of what was then known as TH-

If the town does believe that there is a longer public right of way than what is currently shown on the town highway map, then we can start looking at how we can get it back on the map.

I realize that the information provided above can be a lot to process, so I'd be happy to answer any questions by phone or email.
