

Thank you for your response, and I apologize if I was unclear in my previous email! I intended to say that nothing more had to be done by the Town of Chelsea in order for the VTrans Mapping Section to sign and process the Mileage Certificate with the modification described in that email.

Our normal procedure is to assemble a Mileage Certificate "packet" that includes the Certificate along with any related documentation and correspondence, and explanatory notes for any adjustments made to the Certificate. It is then signed by VTrans, posted to the online Mileage Certificate Archive, and a copy is sent to the Town of Chelsea by email. I believe that copy should meet the Town's needs, but please let me know if you have additional concerns.

Greetings to the Chelsea Selectboard,


After speaking with Road Foreman Rick Ackerman in March it became clear that the updates the Mapping Section made to CL3 TH-80 (Cemetery Rd) should not have affected the mileage of TH-80, and therefore we shouldn't have asked the Town of Chelsea to submit +0.07 mi CL3 TH-80 onto the 2024 Mileage Certificate. The Town need not take any action to correct this, as I will cross out that change on the Certificate, and add a note referencing this email (which will be attached to the Certificate) as an explanation. I apologize for any confusion our initial request may have caused!


For a deeper understanding of this change, please see the attached maps indicating how TH-80 was mapped before and after we made the updates to our data. If TH-80 begins near the intersection with Taylor Hill Rd and ends just past the drive to 2541 Cemetery St (as indicated by Rick Ackerman), then the 0.10 miles we had in our records for TH-80 was already correct and doesn't need to be updated. The length of TH-80 can be reevaluated in the future if any documentation is found indicating that it should be mapped differently than shown on the attached "AfterUpdates" map.



Hello Rick,

Thanks for taking the time to speak with me yesterday about Cemetery St and the other Chelsea highways!

Here is an image of Hopkins Rd in the vicinity of the Chelsea/Brookfield Town Line. It is a good example of why surveyors have a challenging job! I've indicated where the speed limit sign and the turnaround are, and also the location that is about 0.55 mi from the intersection with Williamstown Rd. It also shows the VTrans digital data for the Town Line highlighted in light blue and the E911 addresses for each house. I have no convincing reason to believe that any of these theoretical locations is more accurate than the others, and it is quite possible that there are no blazes/monuments to find either, so don't go too far out of your way to look for anything. If you do find something, however, that would be helpful!



I will also reach out to Karen to see if she knows who else might have this information. Who knows, it might even be on a survey map!

Good afternoon Rick,

I left you a phone message on Friday, but I thought it might also be helpful for me to write down my questions for you before we speak. I will try to reach you again today, but could you give me a call (802-917-2621) when you are free if haven't reached you by then?

I'm processing Chelsea's 2024 Mileage Certificate, and would like more information to make sure I am correctly mapping the location where Cemetery St (class 3 TH-80) becomes LT-1. We added the Legal Trail to our records in 1999, but its extent was determined using a measure (0.45 mi) instead of landmarks, which has caused some inconsistency in our data, so I'm hoping that there are landmarks that will clarify where the southern end of the Legal Trail should be mapped.

Question 1: Is there a class 3 portion of Cemetery St north of Taylor Hill Rd (i.e. maintained by the town, and plowed in the winter) or is it considered to be partially class 4 or all Legal Trail?

Question 2: Where is the southern end of LT-1 located? I have three guesses (see #1-3 on the image with property lines showing Cemetery St north of Taylor Hill Rd), though it's possible that none of my guesses are correct:

Guess 1 - Is the southern end of the LT located where Cemetery St reaches the property now owned by Lori Morrow?

Guess 2 - Or near the drive to 2541 Cemetery St?


Guess 3 - Or near the drive to 2566 Cemetery St (on the property of Lori Morrow)? However, it also occurred to me that the house on this property was probably built after the Legal Trail was established in 1999, which might make one of my first two guesses more likely.

Question 3: Is the exact location of the Chelsea-Brookfield Town line along Cemetery St known (based on blazes or monuments)?



Unrelated questions about other Town Highways in Chelsea:

- 1. Is the precise location of the Town Line between Chelsea and Brookfield known along Hopkins Rd (TH-5)? It is possible that this town highway is 0.02 mi longer than we realized.
- 2. We are showing a class 3 Town Highway (Scadin Rd, TH-57) running northeast off VT-113 (see image below). Based on Google StreetView images, this road appears to no longer be maintained (see last image below). Do you know if this road has been reclassified or discontinued?
- 3. Are there any other potential errors that you can see on the current version of Chelsea's Town Highway Map (link to PDF below)? We're particularly interested in knowing that we accurately show which town highways are paved, if there are town highways that are missing from the map, or if any of the mapped highways have been discontinued or otherwise changed legal status.



Hi Karen and Kasey,

We recently sent you the Mileage Certificate for 2024 to be signed by you and the Selectboard. We are not sure if you had any changes, but we do have one that came up after we sent it to you that we would like to update and get the Selectboard's approval. We have been working with Brookfield on updating Taylor Hill Rd and noticed that the intersection with that and Cemetery St. is not currently mapped correctly. The roads in yellow in the image below were being counted in Brookfield and not in Chelsea but as you can see from the pink Town Boundary, they should be counted in Chelsea. We are fixing this mileage in Brookfield and for Chelsea the mileage change would be as follows:

+0.01 mi CL4 TH-84 (Taylor Hill Rd) added - (enter this in the new highways section on the certificate) +0.07 mi CL3 TH-80 (Cemetery St.) remeasured - (enter this in the reclassified/remeasured section on the certificate)
