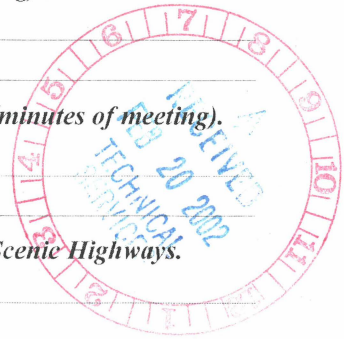

Enclosure one forwards the Village and Town of Northfield certificate(s) of Highway mileage received as reference a.

The municipal attorney, manager and Selectboard determined the reclassification of 1989 was not valid and the road was restored at Town expense. The change of mileage of 0.100 reflects this discovery and I forward the certificate of mileage endorsing the increase of 0.100 in class three roads.

The determination was made that the process back in 1989 was inconsistent with State statutes.
