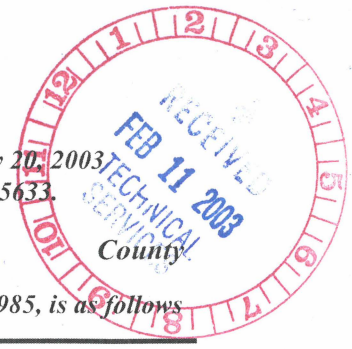




Dear Mike,


Per our phone conversation of 1/22/03
