CERTIFICATE OF COMPLETION  
AND  
ACCEPTANCE AS PUBLIC HIGHWAYS  
WILMINGTON, VERMONT

WHEREAS, Windham Superior Court, in the matter of Chimney Hill Owners Association, Inc., et al, v. Town of Wilmington, Civil Action Docket No: S461-12-96 Wmcv, Honorable John P. Meaker, presiding, issued a Judgment dated 23 December 1998;

WHEREAS, on or about April 27, 2001 Chimney Hill Owners Association, Inc., gave notice to the Board of Selectmen for the Town of Wilmington it would prepare the following roads for acceptance by the Town of Wilmington during 2001: Splatterfoot Close, Rock Split Way, Scattered Timber Road, Three Streams Way, Pond Loop, Bullet Hole Road and K Loop.

WHEREAS, Splatterfoot Close, Rock Split Way, Scattered Timber Road, Three Streams Way, Pond Loop, Bullet Hole Road and K Loop have been surveyed by William R. Creamer, a Vermont licensed professional surveyor (No. 681) of Dauchy-Creamer Associates, LLC, and surveys thereof (entitled "Road Layout of a Portion of Chimney Hill, Wilmington, Windham County, Vermont" dated 11/02/01, Drawing No. DC-0122), have been prepared in accord with the standards set forth in 27 V.S.A. § 1403, mylars of which have been delivered by Chimney Hill Owners Association, Inc., to the Town of Wilmington for recording in the public records;

WHEREAS, Edward H. Floyd, P.E., a Vermont Registered Professional Engineer, has certified that he inspected all work as it progressed and has certified to the Town of Wilmington that all work has been accomplished in accord with the terms of the Judgment; and

WHEREAS, the graveled width of the traveled portions of the roads identified below have been constructed in accord with the provisions of III(c), (d) and (e) of the aforesaid Judgment;

WHEREAS, Chimney Hill Owners Association, Inc., has caused to be executed Warranty Deeds (together with the required accompanying Vermont Property Transfer Tax Returns) conveying to the Town of Wilmington fee title in and to the following roads: SPLATTERFOOT CLOSE, ROCK SPLIT WAY, SCATTERED TIMBER ROAD, THREE STREAMS WAY, POND LOOP, BULLET HOLE ROAD and K LOOP;

WHEREAS, such Warranty Deeds (together with the required accompanying Vermont Property Transfer Tax Returns) have been delivered to the Town of Wilmington for recording in the

Land Records, to which Deeds reference may be had for more particular descriptions of the fee title conveyed;

NOW, THEREFORE, in accord with the terms of the aforesaid Judgment, the Board of Selectmen of the Town of Wilmington accept the aforesaid Engineer's Certification, the aforesaid surveys, and the Easement and Warranty Deeds to Splatterfoot Close, Rock Split Way, Scattered Timber Road, Three Streams Way, Pond Loop, Bullet Hole Road and K Loop, and declare the following to be Class III highways within the Town of Wilmington in accord with the Judgment of the Court and the descriptions thereof contained in the aforesaid surveys and Deeds:

- Splatterfoot Close - length of road .09 miles,
- Rock Split Way - length of road .23 miles,
- Scattered Timber Road - length of road .151 miles,
- Three Streams Way - length of road .248 miles,
- Pond Loop - length of road .378 miles, and
- Bullet Hole Road and K Loop - length of road .169 miles.
