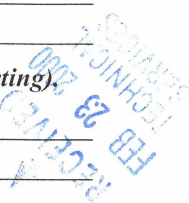

Pursuant to Title 19, V.S.A., Chapter 715, this is to certify that the following described section of Class III (Class 3) Town Highway in the Town of Cavendish is COMPLETED AND OPEN FOR PUBLIC TRAVEL ON FEBRUARY 18, 2000, the date of filing of this certificate with the Town Clerk.

DESCRIPTION OF RIGHT-OF-WAY:



Beginning at a point in the southwest bound of the right-of-way of Depot Street, Town Highway #1, said point is also north 54 degrees west and 124 feet from a fire hydrant in Depot Street; thence the center line runs: S63° - 46'W, a distance of 229 feet to a point; thence N15° - 48'W a distance of 213 feet to a point, said point being in the south bound of the right-of-way of VT Route 131, Main Street.



The right-of-way shall extend 30 feet on each side of said center line. The south bound of the right-of-way is located 10 feet north of the brick and wood frame buildings on the town's property and the west bound is located 13 feet east of the Freeman House Senior Housing Building on the property.

Said roadway is shown on a Highway Map of the Town of Cavendish dated June 26, 1999, and filed in Book 51 on page 160 of the Records of the Town of Cavendish by the Town Clerk of said Town incorporated herein by reference and attested to on said map by said Town Clerk.

A ceremony regarding the acceptance of this road took place on site at a duly warned meeting of the Cavendish Board of Selectmen on June 26, 1999 at 1:30 PM. This road is officially designated as "Village Green."


