WARRANTY DEED

KNOW ALL BY THESE PRESENTS that we, Michael D. Blood and Donna M. Blood of White River Junction, in the County of Windsor, and State of Vermont, Grantors, in the consideration of One Dollar and other good and valuable consideration, paid to our full satisfaction by the Town of Hartford, in the County of Windsor, and State of Vermont, Grantee, by these presents, do freely **GIVE, GRANT, SELL, CONVEY and CONFIRM** unto the said Grantee, Town of Hartford, and its successors and assigns forever, a certain piece of land in White River Junction, County of Windsor, and State of Vermont, described as follows:

Being all and the same lands and premises known as Vermont Drive, so-called, as shown on a plan entitled "Michael and Donna Blood, 91 Christian Street, White River Jct., Vermont 05001" Hathorn Surveys', Proj. No. 101496, Dated 2/20/96, and filed in the Hartford Map Records at Plan No. 304-A, these premises being a portion of the lands and premises conveyed to Michael D. Blood and Donna M. Blood by Warranty Deed of Jeannette B. Fournier, Trustee of the Jeannette B. Fournier Revocable Trust, dated June 30, 1987, and recorded July 1, 1987 at Book 129, Pages 81-82 of the Hartford Land Records.

Reference should be made to the above-mentioned deeds and records, and to the deeds and records referred to therein for a more complete and particular description of the lands and premises here conveyed.

The purpose of this deed is to convey Vermont Drive to the Town of Hartford for it to become a town road.

TO HAVE AND TO HOLD said granted premises, with all the privileges and appurtenances thereof, to the said Grantee, Town of Hartford, and its successors assigns, to its own use and behoof forever;

And we, the said Grantors, Michael D. Blood and Donna M. Blood, for ourselves and our heirs, executors and administrators, do covenant with the said Grantee, Town of Hartford, and its successors and assigns, that until the ensealing of these presents, we are the sole owners of the premises, and have good right and title to convey the same in the manner aforesaid; that they are **FREE FROM EVERY ENCUMBRANCE**, except as above-noted; and we hereby engage to **WARRANT AND DEFEND** the same against all lawful claims whatever, except as above-noted.
