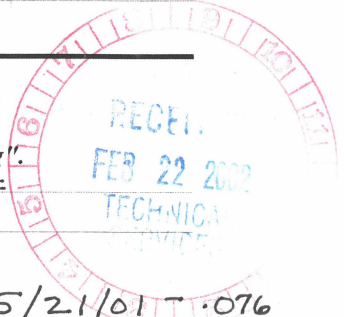

TOWN OF SPRINGFIELD  
ORDER OF DISCONTINUANCE  
PURSUANT TO 19 V.S.A. CHAPTER 7

WHEREAS, pursuant to 19 V.S.A. Section 708(a), on its own Motion after a citizens request, the Selectmen commenced proceedings to discontinue a portion of Town Highway #125 also known as Walter Westney Road, so-called, located in Springfield, Vermont and ending in front of the dwelling owned by Grahame N. Clark, Jr. Management Trust. A viewing was held of such Road on May 14, 2001 at 6:00 p.m. with a Public Hearing held on May 14, 2001 at 7:00 p.m. at the Town Hall, 96 Main Street to consider testimony and take action. Notice of such viewing and Public Hearing was served on all persons owning or interested in lands through which such highway may pass or abut along with the Planning Commission and posting a copy in the office of the Town Clerk and further such notice was published in a local newspaper of general circulation in the area not less than 10 days before the time set for said Hearing. Said notice being waived by Grahame N. Clark, Jr., Trustee of the Grahame N. Clark, Jr. Management Trust. A copy of the Notice is attached and marked as Exhibit A. A copy of the waiver is attached and marked Exhibit B.

WHEREAS, after conducting the viewing of Town Highway 125 and taking testimony, Paul Putnam moved and John Hall seconded a Motion that the Springfield Selectboard hereby finds that the public good, necessity and convenience of the inhabitants of the Town of Springfield requires that the portion of Town Highway 125 located within 382 feet more or less of the Brick House owned by the Grahame N. Clark Jr. Management Trust be discontinued, giving back to the abutting property owner , the Grahame N.

Clark, Jr. Management Trust, any right, title and interest that the Town may have in said road subject however to the condition that Grahame N. Clark, Jr., Trustee of the Grahame N. Clark, Jr. Management Trust Deed to the Town of Springfield an easement for Highway purposes over the parcel depicted on the Survey entitled "Town Road Revision Grahame N. Clark, Jr. Management Trust, Springfield, VT" prepared by Gary Rapanotti, L.S., Project No. 00-620 dated October 24, 2000, as revised, for the purpose of constructing a vehicular turn around area. Said turn around to be constructed to Town specifications by the said Grahame N. Clark, Jr. Management Trust at its cost within 120 days hereof. This Motion was unanimously approved.

The portion of said discontinued highway reverting to the abutting land owner is more particularly described as set forth on the above-referenced Survey and therein described as follows:

To: Grahame N. Clark, Jr., Trustee of the Grahame N. Clark, Jr. Management Trust

Said Trustee, being the only abutting owner to the discontinued roadway, the entirety of said discontinued roadway hereby reverts to Grahame N. Clark, Jr., Trustee of the Grahame N. Clark, Jr. Management Trust, the center line of said discontinued roadway is more particularly described as follows:

Commencing at the point marking the centerline of the hereby discontinued portion of Town Highway #125. Said point being northerly of and 382 feet more or less from the Brick House owned by the Grahame N. Clark, Jr. Management Trust and approximately halfway between points "C" and "B", as shown on the aforementioned Survey, thence in a generally southerly direction along said centerline approximately 382 feet to the end of said road hereby discontinued. The more southerly portion of said highway having been previously discontinued on June 3, 1976. Also meaning and intending to discontinue any such highway


rights concerning the cul de sac at the southerly terminus of the hereby discontinued highway located adjacent to the aforesaid Brick House.

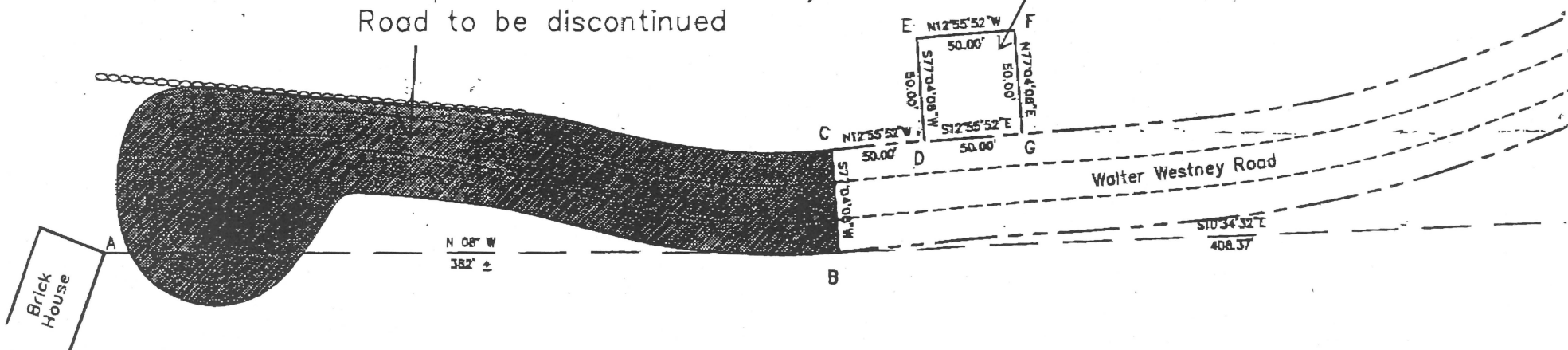
