

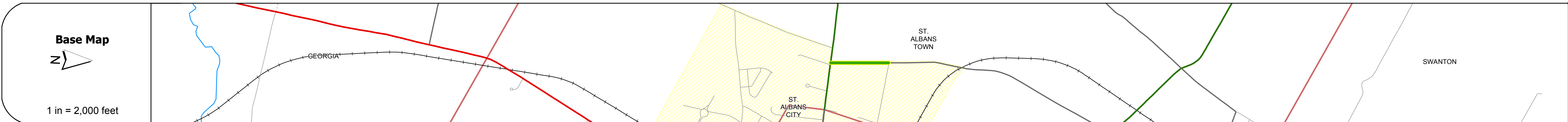
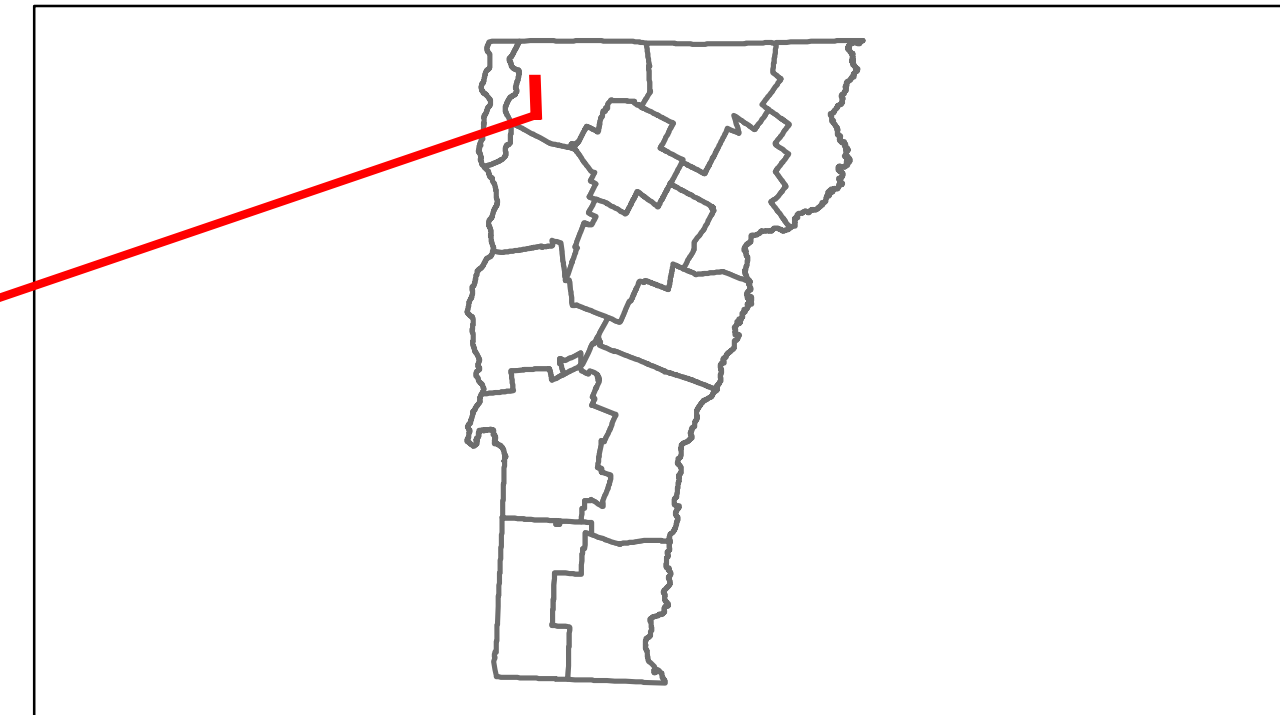


Route Log Progress Chart
