HAY MULCH, ITEM 651.25 TO BE PLACED ON EARTH SLOPES AT THE RATE OF 2 TONS/ACRE.

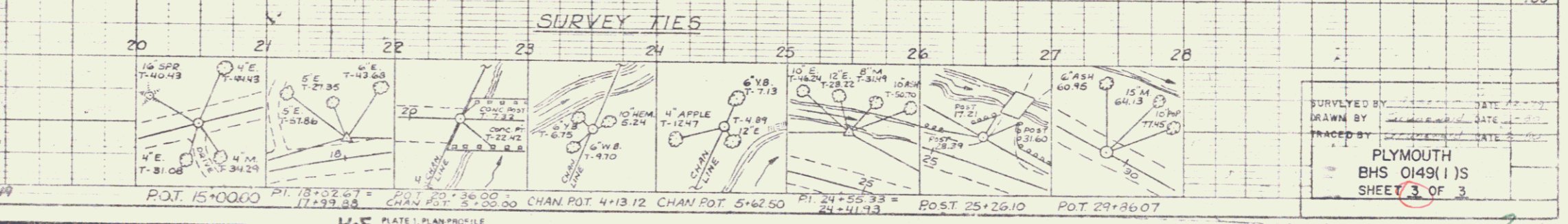
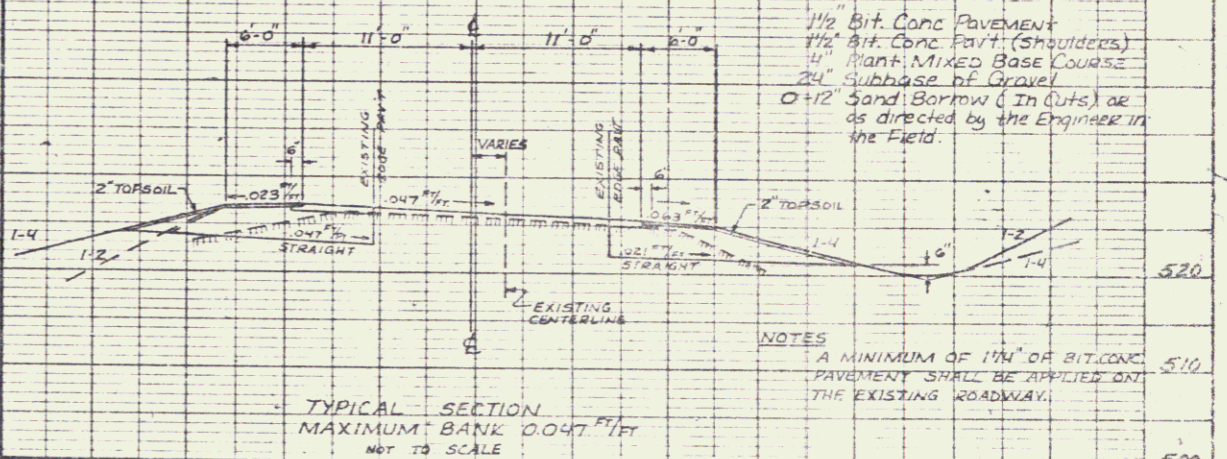
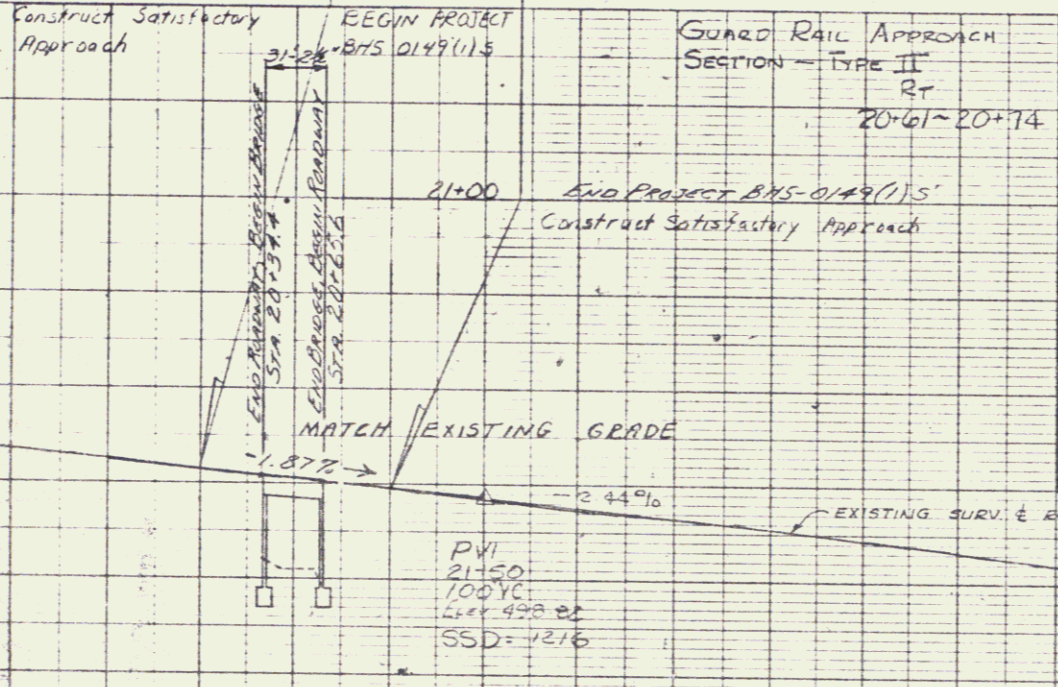
