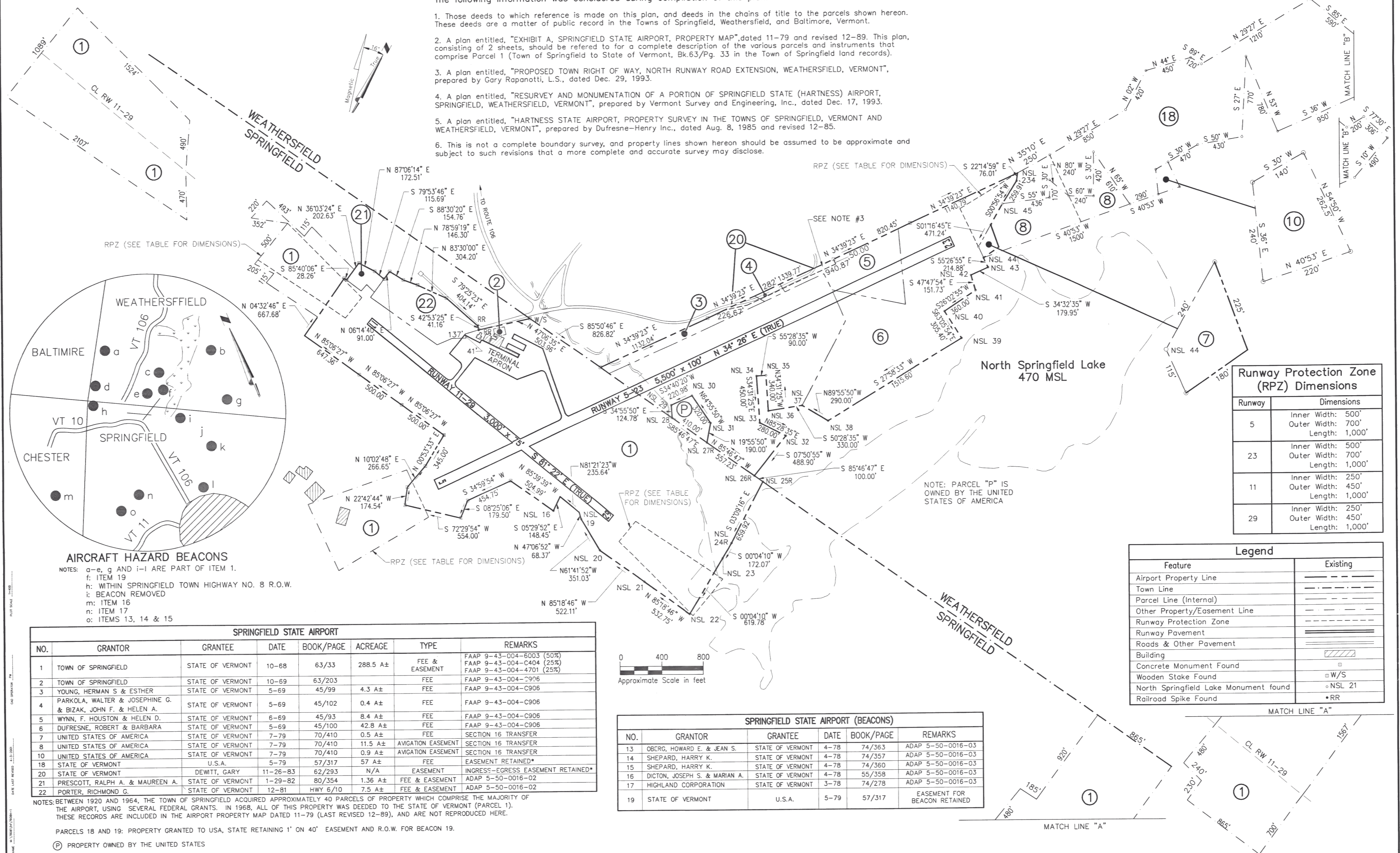


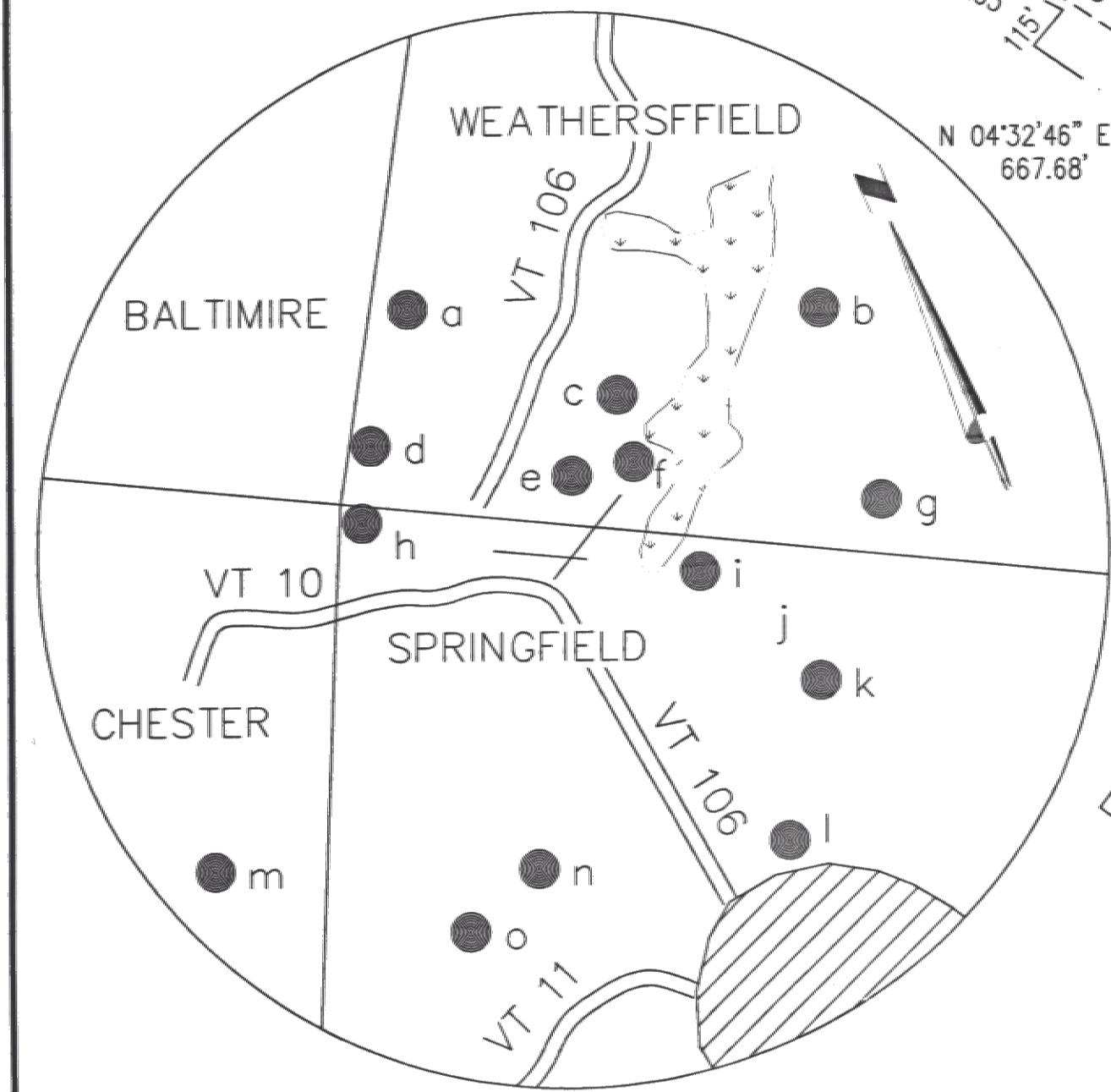
The following information was considered during compilation of this plan:

IN 1968, ALL OF THIS PROPERTY WAS DEEDED TO THE STATE OF VERMONT (PARCEL 1). THESE RECORDS ARE INCLUDED IN THE AIRPORT PROPERTY MAP DATED 11-79 (LAST REVISED 12-89), AND ARE NOT REPRODUCED HERE.
