



BEACON NO. 1 NOTES

- 1) This Right-of-way sketch is based primarily upon deed descriptions and a map entitled "State of Vermont, Barre - Montpelier Airport, Berlin Vermont, Hazard Beacon and Obstruction Lighting Plan, Rights-of-Way & Pole Line" by John D. Cook, C.E. dated July 1955, sheet 8 of 12. The power line sketch is based upon a visual reconnaissance by EIV of the existing conditions of the hazard beacon as of December, 1998.
- 2) The hazard beacon and Right-of-way are located entirely within the lands now owned by Harvey J. and George H. Dodge. Property lines for the Dodge lands are not shown.
